

ORDINANCE NO. 629.

TO VACATE THE STREETS, PUBLIC WAYS, EASEMENTS AND
GROUNDS IN W. D. FULTON'S SESSIONS ADDITION.

Whereas, on the 25 th. day of August, 1925, a petition by the owners of all the lots abutting on the streets, public ways, easements and grounds in W. D. Fulton's Sessions Addition was presented to Council, praying and consenting that said streets, public ways, easements and grounds be vacated; and,

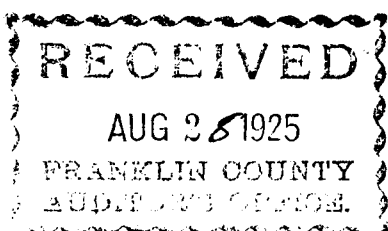
Whereas, Council upon hearing is satisfied that there is good cause for said vacation as prayed for and that it will not be detrimental to the general interest and ought to be made;

NOW THEREFORE, Be it ORDAINED by the Council of the
VILLAGE OF BEALEY, OHIO,

Section. 1. That all the streets, public ways, easements and grounds in W. D. Fulton's Sessions Addition to the Village of Bealey, including -

Preston Road, being all of said Preston Road extending from Broad Street northwardly to the north boundary line of W. D. Fulton's Sessions Addition.

Sessions Place Drive, being all of said Sessions Place Drive extending eastwardly from the southern junction of Preston Road and Sessions Place Drive along the north boundary lines of Lots 17, 16, 15, 14, of said Addition, thence curving northwardly with the northwest boundary line of Lot 13, the west boundary line of Reserve A, and the southwest boundary line of Lot 12, 11, 10, 9, 8, and 7 of said Addition to the north junction of Preston Road and Sessions Place Drive, and being bounded on the west by the southeast line of Lot 19, the east line of Lot 20, and the north line of Lot 19, and said junctions with Preston Road; including therein all public right, interest or use, in a strip of land located in, within or between the north and south driveways of that part of said Sessions Place Drive which lies between Lots 9 to 16.



inclusive, of said addition, said strip of land being marked "Park" on the plat of said Addition.

An easement 10 feet wide extending along the west sides of Lots 1, 2, 3, 4, and 5 of said addition.

an easement 10 feet wide extending along the north sides of Lots 6, 7, 8, 9, 10, 11 and 12 of said addition.

an easement 10 feet wide extending along the east side of Lot 12 of said addition.

An easement 10 feet wide and extending 5 feet in width on either side of the line between Lots 2 and 3 of said addition.

An easement 10 feet wide and extending 5 feet in width on either side of the line between Lots 4 and 5 of said addition.

be, and the same are hereby vacated.

Section 2. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
