ORDINANCE NO. 532

To vacate Franklin Street from the east side of Clinton Street easterly to the west line of the property of the Board of Education Canal Winchester Village School District.

Whereas, the portion of Franklin Street in the Village of Canal Winchester extending from the east side of Clinton Street easterly to land owned by the said Board of Education of the Canal Winchester Village School District, being that portion of Franklin Street adjoined by lots Nos. 9, 10, 13 and 14 of John Coleman's Addition to the Village of Canal Winchester, has for several years been used by the said Board of Education of the Canal Winchester Village School District as a part of the school grounds of the said Board of Education; and

Whereas, the Board of Education of the Canal Winchester Village School District is the owner of said lots Nos. 9, 13 and 14, and is the only interested party as to such lot; and

Whereas, Francis Bitler is the owner of said lot No. 10 and is the only interested party as to such lot; and

Whereas, the Board of Education of the Canal Winchester Village School District is desirous of having said portion of Franklin Street vacated and obtaining the land thus vacated for school purposes; and

Whereas, the said Francis Bitler has presented to the Council of the Village of Canal Winchester, Ohio, his written consent to the vacation of the aforesaid portion of Franklin Street and to having it become a part of the grounds of the Board of Education of the Canal Winchester Village School District for use as school grounds; and

Whereas, the Board of Education of the Canal Winchester Village School District has presented to the Council of the Village of Canal Winchester, Ohio, a certified true copy of a resolution passed by the said Board of Education of the Canal Winchester Village School District on February 10, 1948, consenting and requesting that the Council of the Village of Canal Winchester, Ohio, vacate the aforesaid portion of Franklin Street; and

Whereas, it will not be in anywise detrimental to the use of the property adjoining the said portion of Franklin Street to vacate said portion of said street; and

Whereas, the Council of the Village of Canal Winchester, Ohio, upon hearing is satisfied that there is good cause for such vacation,

and that it will not be detrimental to the general interests, and ought to be made; now therefore,

Be it ordained by the Council of the Village of Canal Winchester, Ohio,

Section 1. That Franklin Street from the east side of Clinton Street easterly to the land owned by the Board of Education of the Canal Winchester Village School District, being that portion of Franklin Street adjoined by lots Nos. 9, 10, 13 and 14 of John Coleman's Addition to said Village, be and the same is hereby vacated.

This ordinance shall take effect and be in full force from and after the earliest period allowed by law.
