the lease term, Lessee shall pay Lessee annual Administrative Fee which shall be comprised of two charges and shall be due on each anniversary date of the issuance of notes and bonds: (1) a payment of one eighth of one percent (.125%) of the aggregate amount of principal and interest on bonds outstanding ten days before the anniversary date of the issuance of said bonds for the acquisition or refinancing of the Demised Premises until such time as the Bonds are paid in full and (2) the amount of reasonable expenses incurred by the City in selling the notes and bonds during the years preceding the anniversary date. The total of the two charges comprising the Administrative Fee shall not exceed \$2,500 in any year. If any payment of Administrative Fee is made other than on an anniversary date, it shall be prorated to the date of payment by multiplying the amount of Administrative Fee times a fraction whose numerator is the number of days from the last Administrative Fee payment to the anniversary date and whose denominator is 365.

ORD. No. 186-82—To amend Section 1 of Ordinance No. 902-69, as amended by Ordinance No. 314-70, Ordinance No. 207-72, Ordinance No. 1874-74, Ordinance No. 1078-76 and Ordinance No. 222-80, to set hourly rates paid by the City Attorney for Negotiations in the Division of Land Acquisition and to declare an emergency.

Whereas, in order to allow Negotiators hired by the City Attorney in the Division of Land Acquisition to have hourly pay increases from time to time, it is necessary to amend Section 1 of Ordinance No. 902-69, as previously amended by Ordinances 314-70, 1874-74, 1078-76 and 222-80; and

Whereas, an emergency exists in the usual daily operation of the City Attorney's Office, Division of Land Acquisition, in that it is immediately necessary to further amend Section 1 of Ordinance 902-69, passed July 7, 1969 for the immediate preservation of public health, peace, property and safety; now, therefore,

Be it ordained by the Council of the City of Columbus:

Section 1. That Section 1 of Ordinance No. 902-69, as amended by Ordinance No. 314-70, Ordinance No. 207-72, Ordinance No. 1874-74, Ordinance No. 1078-76 and Ordinance No. 222-80, be and the same hereby is amended to read as follows:

Section 1. That the City Attorney be and he hereby is authorized and directed to hire Negotiators, from time to time, at the rate of not less than \$6.00 nor more than \$16.00 per hour.

Section 2. That the existing Section 1 of Ordinance No. 902-69 as amended by Ordinance No. 314-70, Ordinance No. 207-72, Ordinance No. 1874-74, Ordinance No. 1078-76 and Ordinance No. 222-80, be and the same hereby is repealed.

Section 3. That in all other respects Ordinance No. 902-69 passed July 7, 1969 shall remain unchanged.

Section 4. That for the reasons stated in the preamble hereto which is hereby made a part hereof, this ordinance is declared to be an emergency measure and shall take effect and be in force from and after its passage and approval by the Mayor, or ten days after passage if the Mayor neither approves nor disapproves the same.

ORD. No. 206-82—To authorize the Finance Director to pay for continued support of the Columbus and Franklin County Disaster Service Agency's program, and to authorize the expenditure of \$35,000 from the General Revenue Sharing Fund, Subfund 02-172, Department 43-01. (\$35,000)

Whereas, it is in the best interest of the City to authorize payment to the Columbus and Franklin County Disaster Service Agency for the City's continued participation in their program during 1982; now, therefore,

Be it ordained by the Council of the City of Columbus:

Section 1. That the Director of the Department of Finance is hereby authorized to pay \$35,000 for continued support of the Columbus and Franklin County Disaster Service Agency during 1982.

Section 2. That the expenditure of \$35,000 is hereby authorized from the General Revenue Sharing Fund, Subfund 02-172, Department of Finance, Department No. 43-01, Index Code 433029, Character 03, Minor Object Code 337 to pay the City's 1982 costs thereof.

ORD. No. 207-82—To authorize the Director of the Department of Finance to extend Contract No. 306512 with Franklin County for participating in the County's Animal Control Program during 1982 and to authorize the expenditure of \$100,000. (\$100,000)

Whereas, it is in the best interest of the City to extend the Animal Control Contract between the City and Franklin County for participation in the County's Animal Control program, now, therefore,

ORD. No. 209-82—To vacate the first alley South of Reynolds Avenue and the alley west of Cleveland Avenue, both between specified limits, subject to retention of easement rights for various utilities.

Whereas, petition, properly signed by abutting owner, has been received by the office of the City Engineer, requesting these alleys to be vacated; and

Whereas, after investigation, it has been determined that the vacation of these alleys should have no detrimental effects on surrounding properties and the request should be granted; now, therefore,

Be it ordained by the Council of the City of Columbus:

Section 1. That the first alley south of Reynolds Avenue, from the west line of Cleveland Avenue to its western terminus, and the alley west of Cleveland Avenue, from its southern terminus to a point 22.80 feet northward therefrom, be and the same are hereby vacated.

Section 2. That the City of Columbus reserves the right to operate and maintain any and all sewers, water lines, and any other public utilities owned by the City; and that the right is reserved to operate and maintain any other public utilities now existing on or in said alleys hereby vacated; and it shall have the right to enter thereon at any time for the purpose of constructing, installing, replacing, operating and maintaining the same.

Section 3. That this ordinance shall take effect and be in force from and after the earliest period allowed by law.

ORD. No. 210-82—To vacate the first alley south of East Long Street, between specified limits, subject to retention of easement rights for various utilities.

Whereas, petition, properly signed by abutting owners, has been received by the office of the City Engineer, requesting the vacation of this alley; and

Whereas, after investigation, it has been determined that this vacation will not have any adverse effects on surrounding properties and should be granted; and

Whereas, facilities exist in the area for the Division of Sewerage and Drainage and the Division of Electricity, and access to same must be maintained; now, therefore,

Be it ordained by the Council of the City of Columbus:

Section 1. That the first alley south of East Long Street, from the west line of Monroe Avenue to the east line of Tallmadge Street, be and the same is hereby vacated.

Section 2. That the City of Columbus reserves the right to operate and maintain any and all sewers, water lines, and any other public utilities owned by the City; and that the right is reserved to operate and maintain any other public utilities now existing on or in said alley hereby vacated; and it shall have the right to enter thereon at any time for the purpose of constructing, installing, replacing, operating and maintaining the same.

Section 3. That this ordinance shall take effect and be in force from and after the earliest period allowed by law.
