ORD. No. 2-88—To amend Administrative Salary Ordinance No. 790-87, as amended, by amending Section 5(D)-S120, the classification of Sewer Service Supervisor (Emergency), and Section 5(D)-W255, the classification of Water service Supervisor (Emergency).

Whereas, the Department of Public Utilities and Aviation requests the adjustment of the pay range for the classifications of Sewer Service Supervisor (Emergency) and Water

Service Supervisor (Emergency); Now, Therefore

Be it ordained by the Council of the City of Columbus:

ORD. No. 4-88—To change the name of the proposed Vinda Blvd., from Deer Crossing Lane to Park Road, to Worthington Woods Blvd., thereby allowing for easier identification of properties in the area.

Whereas, in 1979 Romanelli & Hughes Building Company (hereinafter "Builders") platted Deer Creek Section Two (hereinafter "Plat"); and

Whereas, Vinda Blvd., a platted street between Deer Crossing Lane and Park Road, shown on said Plat was never constructed; and

Whereas, Worthington Woods Blvd., has since been constructed and now abuts the proposed Vinda Blvd. at Deer Crossing Lane; and

Whereas, the Builders are now prepared to construct the proposed Vinda Blvd.; and

Whereas, for easier identification of the area, the Builders would like to change the name of the proposed road from Vinda Blvd to Worthington Woods Blvd.; and

Whereas, after investigation the Engineering and Construction Division of the Department of Public Service recommends the Builders be allowed to change the name of the proposed Vinda Blvd. to Worthington Woods Blvd.; now, therefore

Be it ordained by the Council of the City of Columbus:

Section 1. that the name of the proposed Vinda Blvd. from Deer Crossing Lane to Park Road be and hereby is changed to Worthington Woods Blvd.
