Whereas, after investigation, it has been determined that this vacation will not have any adverse effects on surrounding properties and should be granted; and

Whereas, facilities exist in Washington Avenue for Columbia Gas of Ohio, Division of Sewerage and Drainage, and Division of Water, and facilities exist in Jefferson Avenue for the Division of Sewerage and Drainage and the Division of Water, and access to same must be maintained; now, therefore,

Be it ordained by the Council of the City of Columbus:

Section 1. That the following two streets be and the same are hereby vacated:

WASHINGTON AVENUE, from the north line of Naghten Street to a point 27.6' south-

erly;
JEFFERSON AVENUE, from a point 17' north of the north line of Lot #218, North Park Place Addition, to the south line of Mt. Vernon Avenue.

That the City of Columbus reserves the right to operate and maintain any and all sewers, water lines, and any other public utilities owned by the City; and that the right is reserved to operate and maintain any other public utilities now existing on or in said streets hereby vacated; and it shall have the right to enter thereon at any time for the purpose of constructing, installing, replacing, operating and maintaining the same.
