AN ORDINANCE No. 488-57—To authorize the extension of Contract No. 1884 with M-C-G Co., Inc. for furnishing precast filter bottoms to the Dublin Road Plant for the Division of Water, Department of Public Service, and to appropriate the funds therefor.

Whereas, pursuant to Ordinance No. 1098-56, passed September 10, 1956, the Board of Purchase entered into contract No. 4884 with the M-C-G Co., Inc. for furnishing and delivering precast filter bottoms to the Dublin Road Plant, and

Whereas, it had been determined that the original ten filters at the Dublin Road Plant required rebuilding and contracts have been entered into with the M-C-G Co., Inc. to furnish the necessary precast bottoms to rebuild six of the filters, and

Whereas, the precast filter bottoms now in service in the Dublin Road and the Nelson Road Plants have proven entirely satisfactory, and the only manufacturer and source of supply of this filter bottom is the M-C-G Co., Inc., who notified us that there is no change in the present contract price, and

Whereas, the filter rebuilding program is now in progress and all other materials have been contracted for except four filter bottoms and it is to the interest of the Division of Water to proceed with the program without delay, and

Whereas, an emergency exists in the usual daily operation of the Division of Water, Department of Public Service, in that it is immediately necessary to extend Contract No. 1098-56 with the M-C-G Co., Inc. in order to secure enough filter bottoms to complete the rebuilding program, for the immediate preservation of public health, peace, property and safety; now, therefore

Be it ordained by the council of the city of Columbus:

Section 1. That the Board of Purchase be and it is hereby authorized and directed to extend Contract No. 1884 with the M-C-G Co., Inc., by the additional amount of four filter bottoms for the Dublin Road Plant.

Sec. 2. That the sum of \$14,040 be and the same is hereby appropriated from Water Works Fund No. 90, Code 201, to pay the cost thereof.

Sec. 3. That for the reasons stated in the preamble hereto, which is made a part hereof, this ordinance is hereby declared to be an emergency measure and shall take effect and be in force from and after its passage and approval by the Mayor.

AN ORDINANCE No. 489-57—To accept the warranty deed of the Federal Glass company and to dedicate the premises therein conveyed for public use.

Whereas, city council, by ordinance No. 490-57, passed April 10, 1957, vacated a part of Hosack street and certain adjacent alleys in the area east of Parsons avenue and north of the T. & O. C. railroad, subject to the deeding of certain land, in lieu thereof, for alley purposes, and

Whereas, deed, conveying such land, has been received; now, therefore,

Be it ordained by the council of the city of Columbus:

Section 1. That the warranty deed, dated March 15, 1957, of the Federal Glass company, for the premises hereinafter described and therein conveyed,

AN ORDINANCE No. 490-57—To vacate part of Hosack street and certain adjacent alleys in the area east of Parsons avenue and north of the T. & O. C. railroad.

Whereas, petition, signed by the owner of all lots and lands abutting upon a part of Hosack street and certain adjacent alleys in the area east of Parsons avenue and north of the T. & O. C. railroad, was duly presented to this council, praying for and consenting to the vacation of said part of Hosack street and certain adjacent alleys, and agreeing to deed, in lieu thereof, certain land for alley purposes, and

Whereas, council, upon hearing, is satisfied there is good cause for such vacations as prayed for in said petition, that they will not be detrimental to the general interests and ought to be made; now, therefore,

Be it ordained by the council of the city of Columbus:

Section 1. That subject to acceptance of deed and dedication of land therein conveyed as an alley for public use, the alley east of Tanoc street, extending from the south line of the alley north of Hosack street to the north line of Merritt street, and easterly of and adjacent to lot No. 62 and lot No. 73 of C. L. & L. C. Marion, et al., subdivision, as the same is shown of record in plat book 5, page 403, recorder's office, Franklin county, Ohio, together with that portion of Hosack street (formerly Ray avenue), from the easterly line of the abovementioned alley westerly to a line 24 feet easterly from the northwesterly corner of the aforesaid lot No. 73 and 24 feet easterly from the southwesterly corner of the aforesaid lot No. 62 and also that portion of the alley between Kian avenue and Hosack street, between the easterly line of the previously mentioned alley and a line 24 feet easterly from the northwesterly corner of the aforesaid lot No. 62, be and the same are hereby vacated.

Sec. 2. That the city of Columbus reserves the right to operate and maintain any and all sewers, water lines and any other public utilities owned by the city, and that the right is reserved to operate and maintain any other public utilities, if any, now existing on or in said street and alleys hereby vacated, and shall have the right to enter thereon at any time for the purpose of replacing, operating and maintaining the same.

Sec. 3. That this ordinance shall take effect and be in force from and after the earliest period allowed by law.

AN ORDINANCE No. 491-57—To vacate the alley west of Eastmoor boulevard, extending from the alley north of Livingston avenue to the second alley north of Livingston avenue.

Whereas, petition, signed by the owners of all lots and lands abutting upon the alley west of Eastmoor boulevard, extending from the alley north of Livingston avenue to the second alley north of Livingston avenue, was duly presented to this council, praying for and consenting to the vacation of said alley, between the points named, and

Whereas, council, upon hearing, is satisfied that there is good cause for such vacation as prayed for in said petition, that it will not be detrimental to the general interests and ought to be made; now, therefore,

Be it ordained by the council of the city of Columbus:

Section 1. That the alley west of Eastmoor boulevard, extending from the north line of the alley north of Livingston avenue to the south line of the second alley north of Livingston avenue, be and the same is hereby vacated.

Sec. 2. That the city of Columbus reserves the right to operate and maintain any and all sewers, water lines and any other public utilities owned by the city, and that the right is reserved to operate and maintain any other public utilities, if any, now existing on or in said alley hereby vacated, and does further reserve unto itself perpetual easements for the full width of the alley for the purpose of installing or constructing any new utility facilities, either publicly or privately owned, which may become necessary, and shall have the right to enter thereon at any time for the purpose of constructing, installing, replacing, operating and maintaining the same.

Sec. 3. That this ordinance shall take effect and be in force from and after the earliest period allowed by law.

AN ORDINANCE No. 492-57—To authorize the Director of Public Service to advertise for, receive and open bids for repairing incinerator furnaces, breechings and stack at the Short Street and McKinley Avenue incinerators.

Whereas, major repairs have not been made on the aforesaid garbage and refuse incinerators for many years and these incinerators and stack are in a state of disrepair; and,

Whereas, an emergency exists in the usual daily operation of the Division of Garbage Disposal, Department of Public Service, in that repairs to incinerators are immediately necessary before the heavy loads of summer garbage and refuse are received, thereby preserving the public health, peace and safety; now, therefore,

Be it ordained by the council of the city of Columbus:

Section 1. That the Director of Public Service be and he is hereby authorized and directed to advertise for bids and open bids for furnishing all labor, materials and equipment necessary to repair and rebuild where necessary number 3 incinerator furnace and combustion chamber roofs, and breechings at Short Street incinerator, and the chimney at McKinley Avenue incinerator, and all necessary appurtenances in connection therewith, in accordance with specifications therefor on file in the office of said Director which are hereby approved.

Sec. 2. That for the reasons stated in the preamble hereto, which is hereby made a part hereof, this ordinance is hereby declared to be an emergency measure and shall take effect and be in force from and after its passage and approval by the Mayor.
