The above employes are for the workhouse on the farm, and the female part of the workhouse, which is maintained in the new police headquarters, shall be under the supervision of the chief of police.

AN ORDINANCE No. 53-33—To authorize the acceptance of the deed of the Masonic Temple Association, dated November 18, 1932, for property therein described, and in exchange therefor to authorize and direct the conveyance of certain property herein described, and doing certain other things herein set forth.

Whereas, in connection with the acquiring of the Masonic Temple Association site, bounded by Long, Water, Scioto and Gay street, extended, by the United States government for a post office site, an agreement was reached by which the Masonic Temple Association is to convey to the city of Columbus all that portion of said tract south of the north line of Gay street, extended, for street and park purposes only, in exchange for which the city of Columbus is to convey to the United States government or the Masonic Temple Association a rectangular tract 17 x 20.5 feet on Scioto street near Long street, and to relocate and rebuild the sewers now located on said proposed site at its own cost and expense; and

Whereas, pursuant thereto, said Masonic Temple Association now tenders to the city of Columbus a deed for said tract south of the north line of Gay street, extended, on the terms and conditions as set forth in the communication on file in the office of the clerk of council of the city of Columbus and attached to the resolution, accepting the proposition, adopted by council October 31, 1932; now, therefore,

Be it ordained by the council of the city of Columbus:

Section 1. That the deed of the Masonic Temple Association, dated November 18, 1932, for the property therein described, being that portion of the Masonic Temple Association site south of the north line of Gay street, extended, for street and park purposes only, and subject to the terms and conditions of said proposition attached to said resolution of October 31, 1932, be and the same is hereby accepted, and in exchange therefor, the mayor and director of public service of the city of Columbus be and they are hereby authorized and directed to execute a deed conveying to the Masonic Temple Association all right, title and interest of the city of Columbus, Ohio, in and to said tract 17 x 20.5 feet, which tract is not needed for any municipal purpose, and which is more particularly described as follows:

Situated in the county of Franklin, state of Ohio and in the city of Co-

lumbus, and being a part of lot 20 of Heffner and Hayden's addition to the city of Columbus, of record in deed book 30, page 465, Franklin county recorder's office, more particularly described as follows:

Beginning at a point on the east line of Riverside drive at a distance of 12.00 feet measured southwardly from a concrete monument marking the intersection of the said east line of Riverside drive with the south line of Long street; thence eastwardly on a line parallel to the said south line of Long street a distance of 17.00 feet; thence southwardly on a line parallel to the said east line of Riverside drive a distance of 20.50 feet to the south line of said lot 20; thence westwardly with the said south line of lot 20 a distance of 17.00 feet to the said east line of Riverside drive; thence northwardly with the said east line of Riverside drive a distance of 20.50 feet to the place of beginning; the above described tract being a part of the premises conveyed by Horatio N. Baker to the city of Columbus by deed recorded July 21, 1920 in deed book 644, page 189, Franklin county recorder's office; and further, said city of Columbus shall, at its own cost and expense, relocate and rebuild the sewers now located on the proposed site for said post office, being that portion of said Masonic Temple Association property north of the north line of Gay street, extended, and which said relocation of sewers has heretofore been authorized by council.

Sec. 2. That that portion of the said property conveyed to the city of Columbus by the Masonic Temple Association, described as follows:

Situated in the county of Franklin, state of Ohio and in the city of Columbus, and being a part of Wm. Phelan's addition to the city of Columbus of record in deed book 33, page 410, Franklin county recorder's office, and of C. A. Platt's subdivision of lots 1 and 2 of the said Wm. Phelan's addition, of record in plat book 1, page 362, Franklin county recorder's office, more particularly described as follows:

Beginning at the intersection of the west line of Water street with the north line of Gay street produced westwardly; thence with the said west line of Water street S. 8°-27' 30" E. 82.50 feet to the south line of Gay street produced westwardly; thence with the said south line of Gay street produced S. 81° 34' 50" W. 109.18 feet to the east line of Riverside drive; thence with the said east line of Riverside drive N. 41° 41' 10" W. 98.67 feet to the said north line of Gay street produced westwardly; thence with the said north line of Gay street produced N. 81° 34' 50" E. 163.25 feet to the place of beginning;

be and the same is hereby dedicated to public use for the opening and extending of Gay street from Water street to Scioto street.

Sec. 3. The city of Columbus, Ohio, hereby waives any and all claims, liens, rights or easements which it may have in or against the premises of the Masonic Temple Association, except taxes and assessments.

Sec. 4. That this ordinance shall take effect and be in force from and after the earliest period allowed by law.

AN ORDINANCE No. 54-33—Authorizing the board of purchase to sell thirty horses and fifteen double sets harness belonging to the city of Columbus and not needed for any municipal purpose.

Whereas, an emergency exists in the usual daily operation of the division of street cleaning, refuse collection and disposal, department of public service, in that it will be necessary to dispose of said horses and harness as soon as possible, due to the fact that they are no longer needed; now, therefore,

Be it ordained by the council of the city of Columbus:

Section 1. That the board of purchase be and it is hereby authorized and directed to advertise for sale and sell to the highest bidder according to law, thirty horses and fifteen double sets harness now used in the department of public service, division of street cleaning, refuse collection and disposal, no longer needed for any municipal purposes; said sale shall be for cash.

Sec. 2. That for the reasons stated in the preamble hereto, this ordinance is declared to be an emergency measure and shall take effect and be in force from and after its passage and approval by the mayor.
