

AUTHORIZING THE CITY, THROUGH THE DIRECTOR OF PUBLIC SERVICE, TO CHANGE THE STREET NAME FROM BRITTON ROAD TO BRITTON PARKWAY WITHIN THE CORPORATE LIMITS OF HILLIARD.

WHEREAS, within the corporation limits of the City of Hilliard, residing in Franklin County, Ohio, Britton Road between Davidson Road and Hayden Run Road is an existing public roadway owned and maintained by the City of Hilliard; and

WHEREAS, the official name of this existing roadway in all City and County records is Britton Road as shown on Exhibit "A" attached hereto; and

WHEREAS, the City of Hilliard has constructed and accepted as public roadways Britton Parkway Section 1 between Cemetery Road and Reynolds Drive, Britton Parkway Section 3 between Hayden Run Road and the City's north corporation limit, and most recently, Britton Parkway Section 2 between Reynolds Drive and Davidson Road; and

WHEREAS, the recent opening of Britton Parkway Section 2 completes the entire Britton corridor between Cemetery Road and the City's northern corporate boundary as shown on attached Exhibit "A"; and

WHEREAS, the City desires to have one name, Britton Parkway, for the entire Britton roadway corridor; and

WHEREAS, it is to the interest and benefit of the City of Hilliard and the public at large that existing Britton Road between Davidson Road and Hayden Run Road be renamed Britton Parkway so as to have a uniform name for the entire roadway corridor.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Hilliard, Ohio that:


SECTION 1. This Council finds that it is to the interest and benefit of the City of Hilliard and public at large that the official street name of existing Britton Road, between Davidson Road and Hayden Run Road, is changed to Britton Parkway. Hereafter this roadway corridor shall be known as Britton Parkway.

SECTION 2. The Director of Public Service is hereby authorized to modify, as necessary, all City documents and maps to reflect this name change to Britton Parkway.

SECTION 3. This Resolution is effective upon its adoption.




