**ORDINANCE 09-2000**

**AN ORDINANCE TO VACATE PORTIONS OF EYRE HALL NORTH, EYRE HALL SOUTH, JAMES RIVER ROAD EAST, AND SHIRLEY LANE, LOCATED IN THE VILLAGE OF NEW ALBANY, OHIO AND BE DECLARED AN EMERGENCY**

**WHEREAS,** The New Albany Company has petitioned for the vacation of portions of Eyre Hall North, Eyre Hall South, James River Road East, and Shirley Lane, located in the Village of New Albany, Ohio, and

**WHEREAS,** the Village Council, upon hearing, is satisfied that there is good cause for such vacation as prayed for in said petition; that it will not be detrimental to the general interests of the citizens of the Village and ought to be made, and

**WHEREAS,** the Village Engineer has reviewed the proposed vacation and dedicated rights-of-way and has no objections to the petitioned vacations, and

**WHEREAS,** no objections to the vacations of those portions of Eyre Hall North, Eyre Hall South, James River Road East, and Shirley Lane, which are located in the Village of New Albany, Ohio were filed; no claims for compensation or damages on account thereof were filed and,

**WHEREAS,** the Village Council of New Albany, Ohio finds that the utilities and amenities now located within the vacation areas and the easements granted by the sub dividers for said utilities and amenities are vacated through the area sought to be vacated, and

**WHEREAS,** it is now necessary to rename those remaining portions of Eyre Hall North and Eyre Hall South to Eyre Hall Pass; to rename James River Road East, east of Eyre Hall Pass to James River Close; and to rename all of Shirley Lane, northeast of Lot 27, to Shirley Court.

ORDINANCE 09-2000

NOW, THEREFORE BE IT ORDAINED by the Council of New Albany, County of Franklin, State of Ohio:

Section 1: That a 0.160 acre and a 0.160 portion of Eyre Hall North and a 0.107 acre and 0.107 acre portion of Eyre Hall South and a 0.076 acre portion of James River Road East and a 0.504 acre portion of Shirley Road be vacated, as further described on the New Albany Country Club Subdivision Plat Section 11 A (attached hereto).


Section 2. That Eyre Hall North and Eyre Hall South is renamed Eyre Hall Pass; that all of James River Road East, east of Eyre Hall Pass is renamed to James River Close; and Shirley Lane northeast of Lot 27 is hereby renamed Shirley Court.

Section 3. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of the Council and that all deliberations of this Council and any decision making bodies of the Municipality of New Albany which resulted in such formal actions were in meetings open to the Public or in compliance with all legal requirements of the Municipality of New Albany, Franklin County, Ohio.

Section 4. That due to the need to preserve the safety and well being of the residents of the Village, the thirty-day waiting period is hereby waived, and this Ordinance shall take effect at the earliest period allowed by law.
