ORDINANCE NO. 390-34

TO VACATE THE ALLEY BETWEEN HENTHORNE ROAD AND NORTH ARLINGTON AVENUE FROM THE SOUTH LINE OF LOT NUMBER 12 OF THE NORTH ARLINGTON ADDITION TO THE NORTH END THEREOF, SAID ALLEY ENDING AT THE NORTH LINE OF LOT NUMBER 1.

Whereas on the 19th day of December, 1934, a petition by all of the persons owning abutting property on the portion of the alley to be vacated to wit: the alley twenty feet in width running north and south between Henthorne Road and North Arlington Avenue, between the South line of lot number 12 of North Arlington Addition to the north end of said alley which ends at the North line of lot number 1 of said Addition, which was duly presented to the commission praying that said alley between the points named be vacated and,

Whereas the publication of notice of said vacation is unnecessary under section 5727 of the General Code of Ohio.

Now Therefore be it ordained by the Commission of the Village of Upper Arlington:

Section 1. That said alley above described be and the same is hereby vacated, provided however, that the wires, lines, pipes and poles of the Village and of the Public Utility Companies operating in said Village, and now in place in said alley shall be maintained in place, and the owners thereof shall have the right of ingress and egress, and to replace, repair and maintain said facilities, and shall have an easement therein and the right to put in any and further wires, lines, pipes and poles which may be necessary to adequately serve the Village and inhabitants thereof.

Section 2. That this ordinance be and remain in force

from and after the earliest period allowed by law.


