

ORDINANCE NO. 54-70

CHANGING THE NAME OF BAGSHAW ROAD WHICH PRESENTLY EXTENDS FROM POTH ROAD TO THE NORTH CORPORATION LINE OF THE CITY OF WHITEHALL, OHIO TO "YEARLING ROAD" AND DECLARING AN EMERGENCY

WHEREAS, there are presently no established addresses on Bagshaw Road from Poth Road to the north corporation line of the City of Whitehall; and

WHEREAS, the present termini of Bagshaw Road will be eliminated both at the point where it intersects with Poth Road on the south and also northerly at the point where it will intersect with the proposed improvement of Yearling Road; and

WHEREAS, it will serve the best interest of the City of Whitehall, Ohio to have the single name of Yearling Road clearly established in order to avoid a conflict in the naming of the Right-of-Way of the proposed improvement of Yearling Road in conjunction with the City of Columbus, Ohio, the County of Franklin, and the Department of Highways, State of Ohio; NOW, THEREFORE,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WHITEHALL, OHIO:

SECTION 1: That the name of the present Bagshaw Road, from Poth Road to the north corporation line of the City of Whitehall, be and is hereby changed to "Yearling Road."

SECTION 2: That this ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public health, peace, safety and welfare and for the further reason that this name change is necessary to accomplish the proposed improvement of Yearling Road; wherefore, this ordinance shall go into full force and effect immediately upon its passage and approval by the Mayor.
