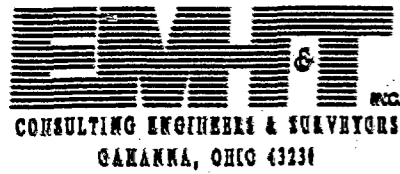

GRAPHIC SCALE (IN FEET)

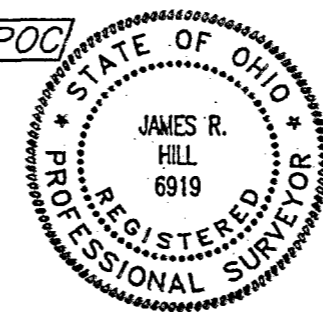
