Occupation, in general, fits survey. Encroachments as shown.

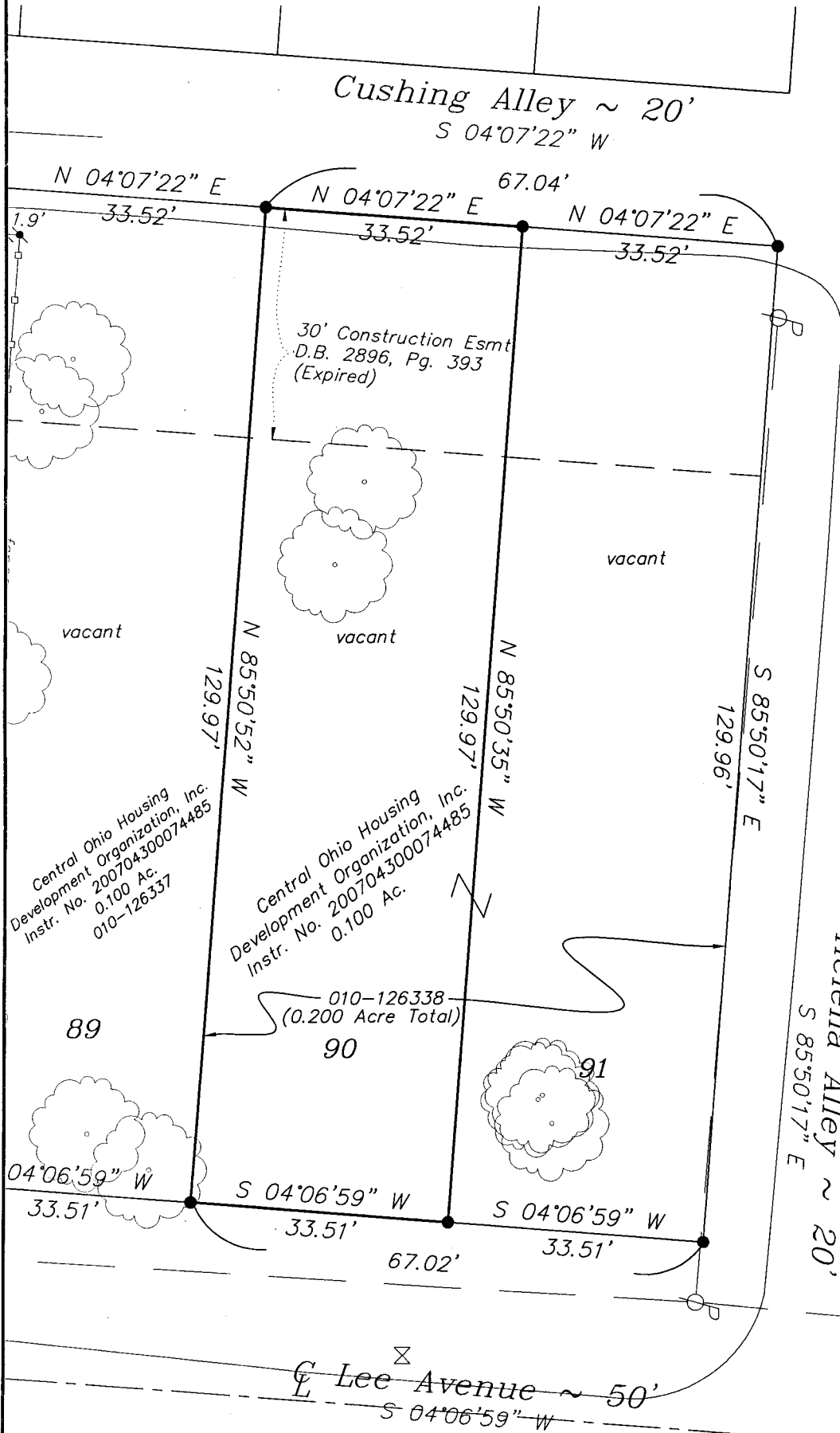
All iron pipes set are 3/4 inch inside diameter by 30 inches in length with an orange plastic cap marked "Geo-Graphics".

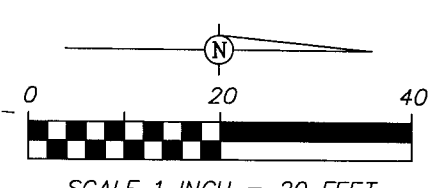

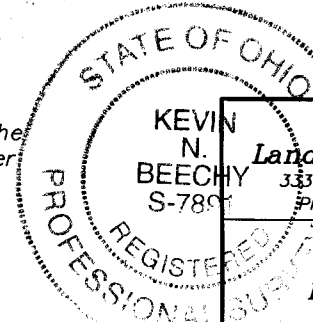
