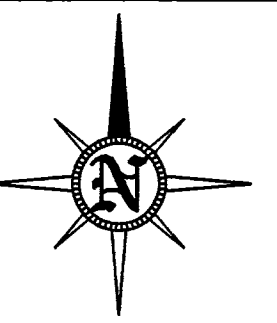
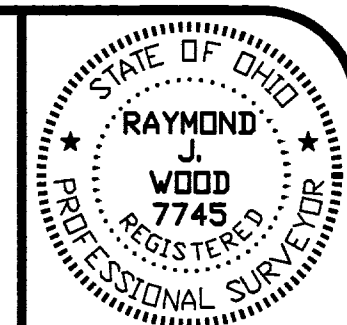


BOUNDARY SURVEY OF 1391 AND 1403 MAIN ST.

SITUATED in the State of Ohio, County of Franklin, City of Columbus, being a part of Half Section 22, Section 14, Township 5, Range 22, Refugee Lands, and being part of Lot 1 of Nathan and Mary Cole's Subdivision, Plat Book (P.B.) 3, pg. 51, and all of Lot 8 of Thomas Miller's Amended Addition, P.B. 2, pg. 228, conveyed to the Victorious Redeemer Full Gospel Church in Instrument (Instr.) No. 200002290039923 (0.769 acres meas.) and in Instr. No. 201201040000829 (0.144 acres meas.), Franklin County Recorders' Office.

The bearings shown hereon are based on the Ohio State Plane Coordinate System, South Zone, NAD83 (CORS). Said bearings originated from a field traverse which was tied to said coordinate system by GPS observations and observations of selected stations in the Ohio Department of Transportation Virtual Reference Station network. The portion of the south right of way line of E. Main St., having a bearing of South 88 degrees 13 minutes 51 seconds East and monumented as described herein, is designated the "basis of bearing" for this survey. All iron pins set are 30" long, 5/8" diameter rebars with a cap stamped "J&J SURVEYING".

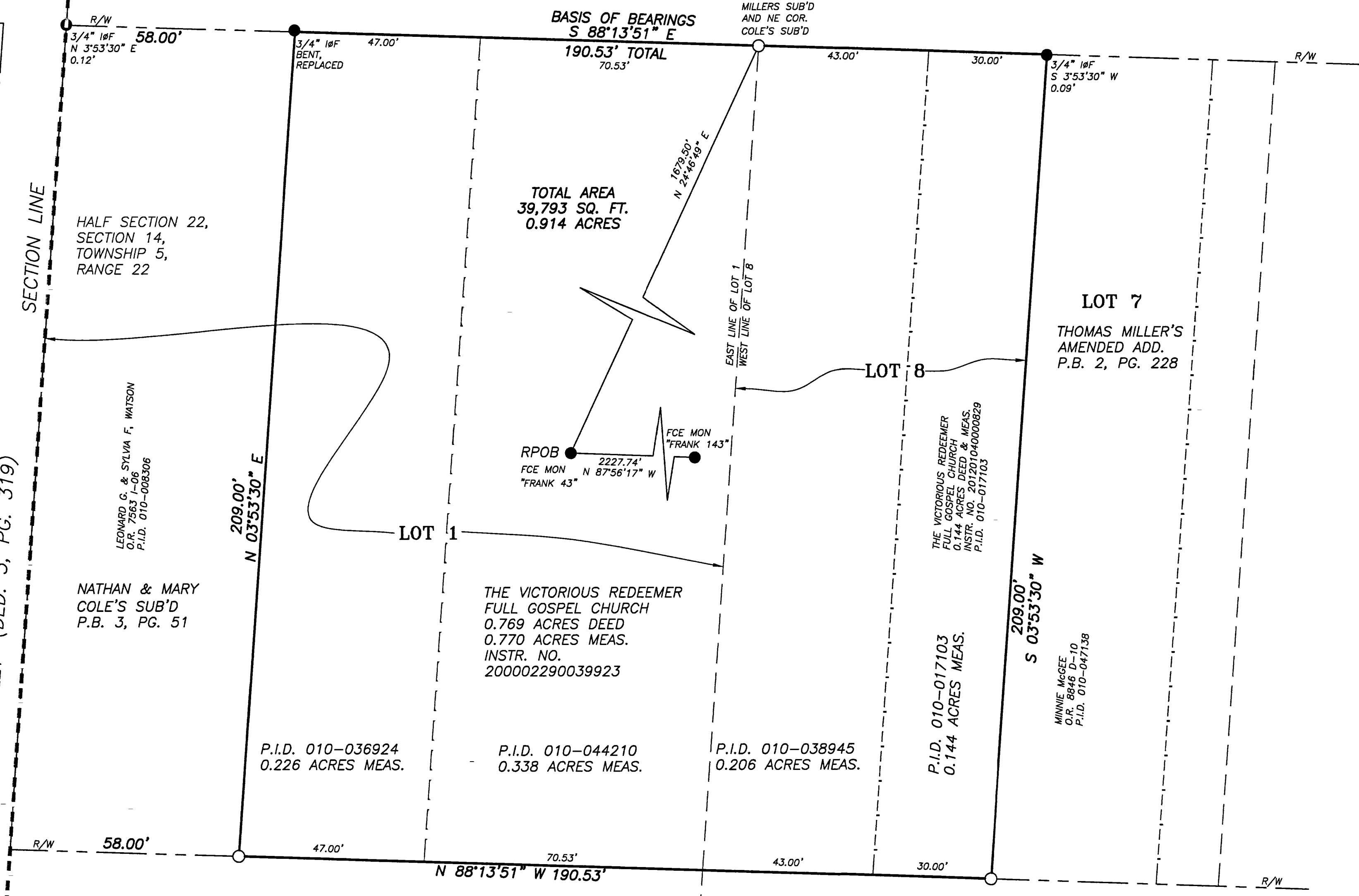
