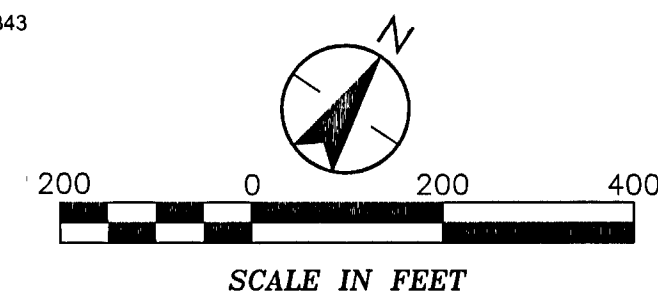
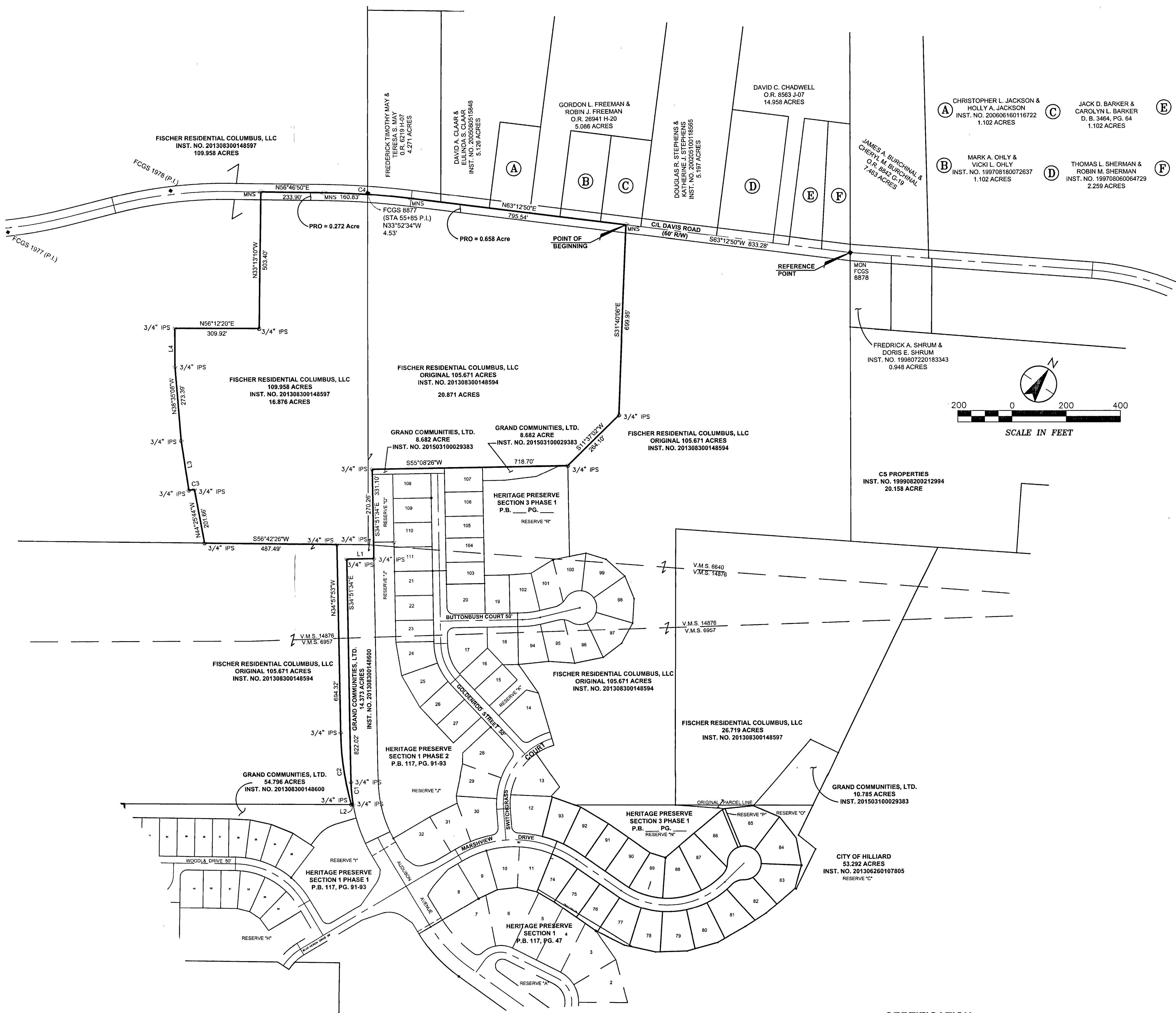
BASIS OF BEARINGS:

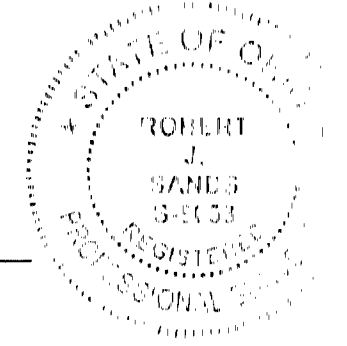
