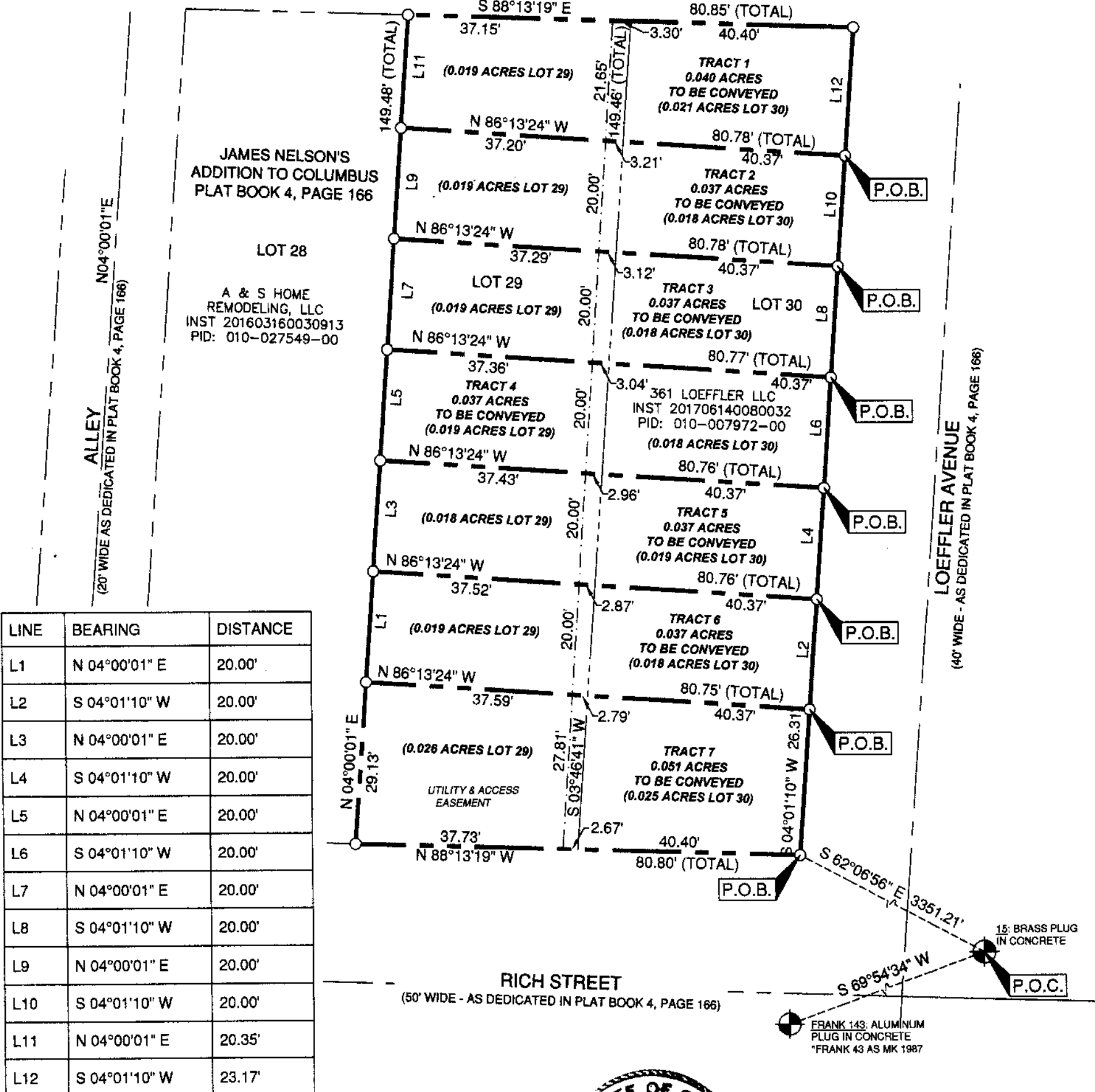
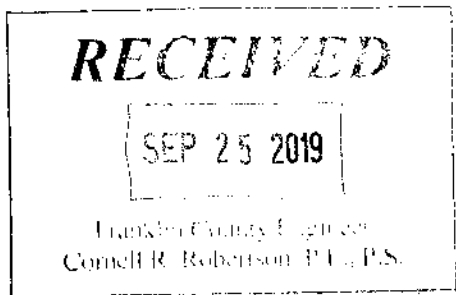
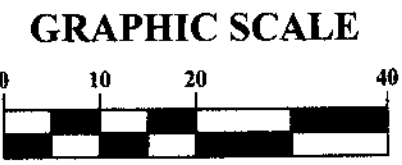


SURVEYOR'S NOTES:
