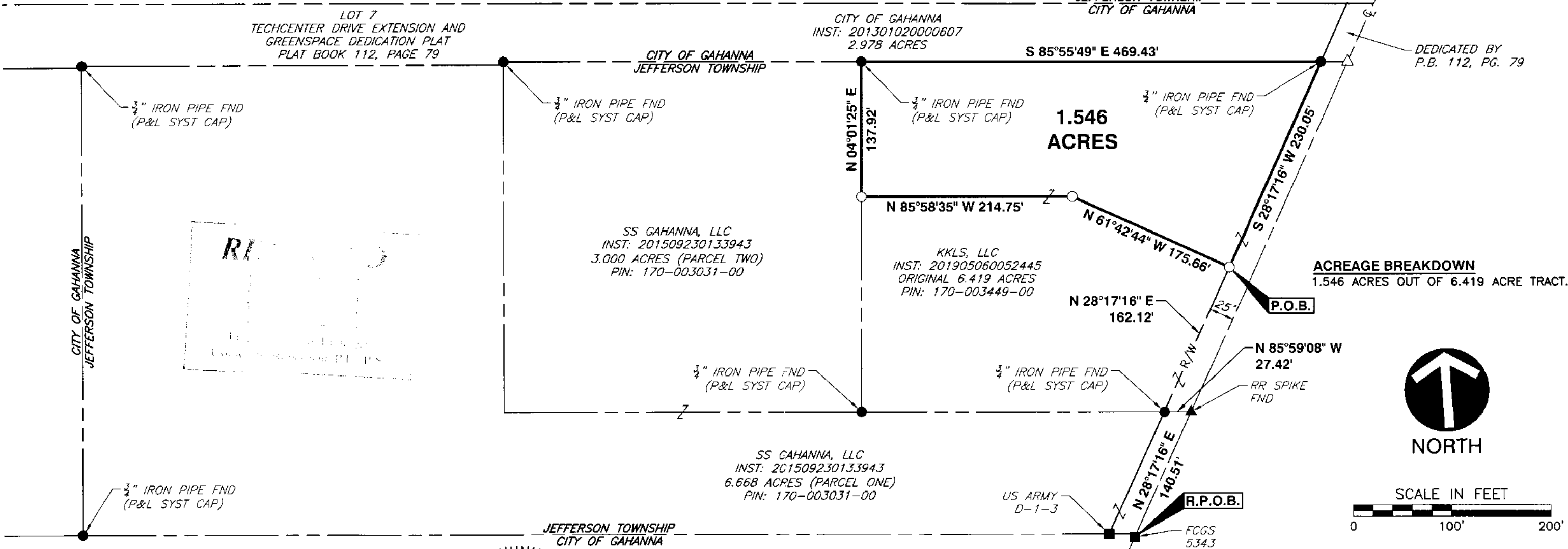

IRON PINS:

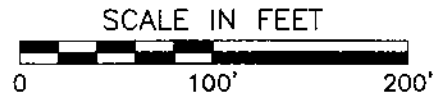

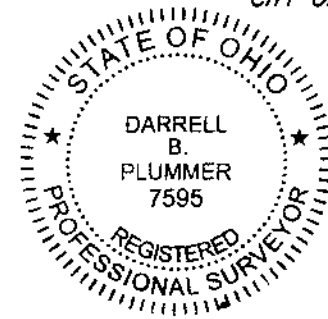


ACREAGE BREAKDOWN
