On the petition of Richard Sedduck and others for a Road beginning at Richard Sedduck's on the Lancaster Road run by E. Schofield the nearest and best ground on the way to Alum Creek bridge making Daniel Ross a point in the Road and from the bridge at Livingston to proceed so to intersect the road leading from Robert Taylor's to Columbus. Viewers having been appointed to run said road and were ordered to proceed according to law, have reported as follows.

In pursuance of above order we proceed to View said route on the day prescribed, and have established the same agreeable to the route for said road. Given under our hands Montgomery --25th August 1815.
