On the petition of Archibald Campbell for a Road beginning on the Pickway County line At the corner No.8 No.9 in Township no.10 Range 21 Matthews Survey running North to Walnut Creek, thence up the creek and between the creek and a place called Leavy's place and by Adam Pontion's house, thence by or near John Ganden's house and thence on the Most Suitable ground until it strikes the Lancaster road. Ordered the same be opened and that R. Breckenridge, Percival Adams and Robert Nelson Viewers and Joseph Vance surveyor meet at the house of A. Campbell on the 25th August next and proceed to View and survey said route and make a report to the Board at their next meeting agreeably to same.
