On the petition of Swayne Beaty and others for a new road to convinence on the North line of George Evans No.3809 on the road generally called the Possum Run Road in Pleasant Township from thence on the Said North line of Said Survey to the end of Said line thence West to intersect the County Road leading from Darbyville to Georgesville in Said Township.

Whereupon the Commissioners of Franklin County appointed John Biggard, Stephen Emery and George Gibson as Viewers Frederick Cole as Surveyor and that they meet at the office of Wm.Walker Esq.in Pleasant Township on the 21st day of May 1836 and after being duly qualified according to law proceed to View Survey Mark and locate Said road or within five days thereafter and a true plat and Survey thereof along with their Report return to this office on or before the 1st Monday in June 1836, Commissioners Office City of Columbus March 7th 1836

The State of Ohio Franklin County Pleasant Township personally appeared before me the Subscriber a Justice of peace for Said Township George Goodson, John Biggart as Viewers and F.Cole as Surveyor and made Oath that they would Serve according to Law to their Respective Offices

Persuant to the annexed order I proceeded on the 21st day of May A.D.1836 under the direction of John Biggart and George Goodson Viewers to make a Survey and location of a County Road as therein directed as follows viz: Beginning at the North line of George Evans Survey No.3809 where it intersects the Possum Run Road so called in Pleasant Township running from thence on the North line of Said Survey West one mile to Hickory Con't smae course to a Honey Locust two miles passing the S.W.corner of Said Evans Survey at 310 poles, Con'td same course two hundred and forty poles to a White Oak in the road leading from georgesville to Darbyville total distance two miles 240 rods. I Certify the above field notes to be correct as taken by me on the grounds and that the above plat is a true prot-raction of the Same .

To the Hon. the Commissioners of Franklin County persuant to an order to us directed from your Hon,body on the 7th March 1836 in answer to a petition of Swayne Beaty and others for a new County Road we proceeded on the day therein named to View the ground and cause the Same to be Surveyed Marked and located would be a public utility we there- for are of the opinion that Said Road ought to be established May 21st 1836
