PLAT AND CERTIFICATE OF THE COLUMBUS AND JOHNSONTOWN STATE ROAD

In persuant of an act passed by the Legislature of Ohio bearing date of March 2nd 1836 to lay out and establish State Road beginning at the town of Columbus Franklin County thence to Judge Reads at Allum Creek thence to Michael Nuinangus thence to Noble Sanders thence to Johnstown which I do Certify this to be a true certificate and draft, To-wit,
