To the honorable board of Commissioners of franklin County Ohio

The undersigned Resident freeholders prays Respectfully that a Change and Vacation of the Road leading from Delaware to Columbus, may be Made Commencing at a point immediately above the house in which Nelson Foos now Resides Running thence on a line with the Mill Race and Round the Cliff of Rocks" thence on the high land immediately above the bottoms" until it intersects the Old Road at a point near O'Harras Saw Mill Said Change in Perry Township A. W. McCoy Robt. Armstead Arthur O'Harra James Grant Alex. Shattuck Jacob Slyh Lewis Mills J. C. Brodrick C. Lynch W. T. Martin E. Backus James Graham Wm Long

On the petition of A. W. McCoy and others for the alteration and Vacation of a part of the State and County Roads leading up the East Side of the Scioto River to Commence at a point immediately above the house in which Nelson Foos now Resides Running thence on a line with the Mill Race- and Round the Cliff of Rocks until it intersects the Old Road at a point near O'Harras Saw Mill Whereupon the Commissioners of franklin County appointed James Walcutt Abram Hunter Isa Davis as Viewers and Wm Johnston as Surveyor of Said alteration and Vacation and that they meet at the office of Miskell Saunders Esq. on the 3rd day of May 1838 or within five days thereafter and after being duly Qualified according to law proceed to View Survey Mark and locate Said alteration and Vacation and a true plat and Survey along with their Report Return to this office on Or before the first Monday in June 1838

Pursuant to the annexed Order I proceeded on the third day of May 1838 under the direction of James Walcutt and Asa Davis Viewers to Make a Survey and location of an Alteration of a part of the State and County Roads leading up the East Side of the Scioto River Petitioned for by A. W. McCoy and others as follows Viz. Beg'g in the Road above the house that Nelson Foos now Resides at a Stake from which an Ash marked B bears S. 62 W 34 links- thence S. 28 30' E. 26 Poles-- thence S. 36 30' E. 86 Poles passing in front of A. Foos house at 66 Poles; thence S. 32 15' E 35 Poles to a Stake in front of A.W. McCoy's Grist Mill-- thence Round the Cliff of Rocks S 4 30' E 18 Poles-- thence S 16 E 35 Poles-- thence S 47' E 10 Poles-- thence on the high land above the bottom S. 53 E 98 Poles to a B. Walnut angle tree-- thence S. 48 E 12 Poles to-- Small Oak Marked 1 Mile and a Same Course 46 Poles-- thence S 58 E 24 Poles to an Elm on the South bank of Haydens Run--- thence S 47 30' E 70 Poles-- thence S 42 E 46 Poles-- thence S 29 15' E 22 Poles to an Oak angle tree-- thence S 26 30 E 19 Poles to a Red Oak angle tree-- thence S 20 E 23 Poles to an Oak angle tree-- thence S. 17 E 70 Poles to a buckeye 2 nd Mile tree-- Same Course 4 Poles-- thence S 20 E 30 Poles to an Oak angle tree-- thence S 48 E 20 Poles to a Stump in the Old Road near O'Harras Saw Mill whole distance 2 Miles and 54 Poles-- length of Old Road between the two points 2 Miles and 45 poles I Certify the above field Notes to be Correct as taken by Me on the ground and that the plat is a true protraction of the Same
