PLAT OF DEDICATION OF THE EXTENSION OF WOODROW AVENUE,  
MARION TOWNSHIP, ACCEPTED BY BOARD OF COUNTY COMMISSIONERS.

PLAT IS INCLUDED IN FRONT COVER SLEEVE

On motion of Mr. Vigor, seconded by Mr. Lauderbaugh, the plat of dedication presented by Dale M. Lawrence, Gladys A. Lawrence, Anita Parish Tallman and Walter Tallman, of the Extension of Woodrow Avenue, Marion Township,

Situate in the State of Ohio, County of Franklin, Township of Marion, and being part of Half-Section 39, Section 26, Township 5, Range 22, Refugee Lands, and being a strip of ground 50 ft. in width out of that land transferred by Will of W. I. Lawrence to Della Harris, by deed, as shown of record in Deed Book 1286, page 254, Recorder's Office, Franklin County, Ohio, the centerline of said strip of ground being more particularly described as follows:

Beginning at the point of intersection of the centerline of Woodrow Avenue, produced Easterly, with the east line of Ellsworth Avenue, shown on plat of Lawrenceedale No. 2, Subdivision, of record in Plat Book 17, page 3, Recorder's Office, Franklin County, Ohio, said point being N. 4°-55' E., along the east line of Ellsworth Avenue, a distance of 25.0 ft. from the northwest corner of a certain parcel conveyed to Ferne Shoaf by deed dated February 3, 1954; thence S. 85°-07' E., along the centerline of Woodrow Avenue, produced Easterly, a distance of 184.0 ft. to the point of termination of the centerline described herein, said point being N. 4°-55' E., a distance of 25.0 ft. from the north easterly corner of the aforementioned parcel conveyed to Ferne Shoaf, said 50 ft. strip containing 0.211 acres,

be, and the same is hereby, accepted by the Board of County Commissioners of Franklin County, Ohio, and said Woodrow Avenue Extension therein dedicated to public use for road and other public purposes pursuant therewith, accepted as such.
