Gentlemen:-

I hereby request that proceedings be initiated by the Board of County Commissioners for the establishing, altering, widening and relocating Hilliard-Rome Road, Section "B" Part, County Road No. 3, Norwich Township upon the following described centerline:

Beginning at a point on the centerline of proposed Hilliard-Rome Road Relocation (to be constructed in conjunction with FRA 70-3.41 project) said point being located approximately 490 feet north of the intersection of the centerline of proposed Hilliard-Rome Road Relocation and Renner Road; thence in a northerly direction a distance of approximately 625 feet to a point on the existing centerline of Hilliard-Rome Road and there to terminate.

The said Hilliard-Rome Road is located in Virginia Military Survey 6641 and 7065, Norwich Township, Franklin County, Ohio.

The above improvement to consist of establishing, altering, widening and relocating the existing 60 foot minimum right-of-way to variable widths, being not less than 100 feet.

If the above request for the above mentioned road improvement is deemed necessary by your Honorable Board, this office will be prepared to view the proposed location with you at your earliest convenience. If so directed by your Board, we are of the opinion that a plat and report could be submitted to your Board on or before September 7, 1967.

ESTABLISHING, ALTERING, WIDENING AND RELOCATING HILLIARD ROME ROAD, SECTION "B" PART, COUNTY ROAD NO. 3, NORWICH TOWNSHIP - BY UNANIMOUS VOTE OF THE BOARD OF COUNTY COMMISSIONERS OF FRANKLIN COUNTY, OHIO, VIEW: THURSDAY, AUGUST 24, 1967, AT 10:00 O'CLOCK A.M. - HEARING: THURSDAY, SEPTEMBER 7, 1967 AT 10:00 O'CLOCK A.M.

Mr. Southwick offered the following preamble and resolution and moved the adoption of the same, which motion was duly seconded by Mr. Koontz.

WHEREAS, Section 5553.04 of the Revised Code of Ohio, provides that when the Board of County Commissioners is of the opinion that it will be necessary for the public convenience and welfare to locate, establish, alter, widen, straighten, vacate or change the direction of a public road it shall so declare by resolution; therefore

BE IT RESOLVED, by the Board of County Commissioners of Franklin County, Ohio, all of said Board being present and voting thereon and in favor thereof, that they do hereby declare that it is necessary for the public convenience and welfare that proceedings be had and taken to establish, alter, widen and relocate the existing 60 foot minimum right-of-way of Hilliard Rome Road, Section "B" Part, County Road No. 3, Norwich Township to variable widths being not less than 100 feet upon the following described centerline:

Beginning at a point on the centerline of proposed Hilliard Rome Road Relocation (to be constructed in conjunction with FRA 703.41 project) said point being located approximately 490 feet north of the intersection of the centerline of proposed Hilliard Rome Road Relocation and Renner Road; thence in a northerly direction a distance of approximately 625 feet to a point on the existing centerline of Hilliard Rome Road and there to terminate. The total length of the road to be established, altered, widened and relocated being approximately 0.12 miles.

The said Hilliard Rome Road is located in Virginia Military Survey 6641 and 7065, Norwich Township, Franklin County, Ohio.

BE IT FURTHER RESOLVED, that Thursday, August 24, 1967, at 10:00 o'clock A.M., Eastern Daylight Saving Time, on the line of said proposed improvement be and the same is hereby fixed as the time and place for viewing same; and that Thursday, September 7, 1967, at 10:00 o'clock A.M., Eastern Daylight Saving Time, at the Office of the Board of County Commissioners of Franklin County, Ohio, be and hereby is fixed as the time and place for final hearing thereon, and that the Clerk of the Board of County Commissioners of Franklin County, Ohio, be and hereby is directed to cause legal publication thereof to be made in accordance with law.

In the matter of the resolution adopted July 27, 1967, by the Board of County Commissioners of Franklin County, Ohio, relative to establishing, altering, widening and relocating Hilliard Rome Road, Section "B" Part, County Road No. 3, Norwich Township, Mr. Koontz offered the following preamble and resolution and moved the adoption of the same, which motion was duly seconded by Mr. Myers.

WHEREAS, on July 27, 1967, the Board of County Commissioners of Franklin County, Ohio, adopted a resolution declaring it necessary to establish, alter, widen and relocate Hilliard Rome Road, Section "B" part, County Road No. 3, Norwich Township; and

WHEREAS, on the 27th day of July, 1967, said Board of County Commissioners did fix the 24th day of August, 1967, at 10:00 o'clock A.M., on the line of said proposed improvement, as the time and place for viewing thereof, and did further fix the 7th day of September, 1967, at 10:00 o'clock A.M., at the Office of the Board of County Commissioners of Franklin County, Ohio, as the time and place for the final hearing on said improvement; and

WHEREAS, legal notice by publication in the Columbus Citizen Journal, a newspaper published in and of general circulation in said County was given of the time and place for the viewing of said establishing, altering, widening and relocating, and of the final hearing thereof; and

WHEREAS, the Board of County Commissioners of Franklin County, Ohio, did on the 24th day of August, 1967, the day fixed for the viewing of the said proposed establishing, altering, widening and relocating, meet on the line thereof, as described in the resolution of July 27, 1967, and heard all the proof offered by parties interested in and affected thereby, and other persons competent to testify, and did go over and along the line of said proposed establishing, altering, widening and relocating and by actual view of same, and the premises along and adjacent thereto which are to be affected thereby, does find that establishing, altering, widening and relocating Hilliard Rome Road, Section "B" Part, County Road No. 3, Norwich Township, is of sufficient importance to require that the Engineer of Franklin County, Ohio, be instructed and directed to make a survey and plat thereof; and

BE IT RESOLVED, by the Board of County Commissioners of Franklin County, Ohio, that the Engineer of Franklin County, Ohio, be and he hereby is, authorized and directed to make a plat and survey of the proposed establishing, altering, widening and relocating Hilliard Rome Road, Section "B" Part, County Road No. 3, an accurate and detailed description of each tract of land, which will be necessary to be taken, together with the names of each owner; shall set stakes, at the termini of each right-of-way line and at all angles between such termini and at sufficient other points in the right-of-way line, so that the bounds of the proposed establishing, altering, widening and relocating may be discernible to property owners and others interested and make a report to the Board of County Commissioners on or before 10:00 o'clock A.M., of Thursday, September 7, 1967; said report shall set forth the opinion of the County Engineer, either for or against the granting of said improvement, which report, together with the plat and survey of the proposed improvement be deposited with the County Commissioners.

Gentlemen:-

Pursuant to your resolution of August 24, 1967, I have made a survey, right-of-way plat, description of lands, and set stakes at the termini of each right-of-way line and at all angles between such termini and at sufficient other points, so that the bounds may be discernible to the property owners and others interested which I hereby submit for the improvement of Hilliard Rome Road, Section "B" Part, County Road No. 3, Norwich Township, along the following described centerline:

Beginning for a reference at the intersection of the centerlines of proposed Hilliard Rome Road and Renner Road; thence north 3° 45' 04" west with and along the proposed Hilliard Rome Relocated centerline a distance of 100.00 feet to a point, said point also being the point of curvature of a 4° 00' 00" curve to the right, the radius of which is 1432.29 feet; thence with and along a portion of said 4° 00' 00" curve to the right, a distance of 358.60 feet to the true place of beginning of this description; thence from this true place of beginning with and along a portion of said 4° 00' 00" curve to the right a distance of 32.53 feet to a point, said point also being the point of a reverse curve to the left, the radius of which is 1432.29 feet, distance of 473.43 feet to a point on the existing centerline of Hilliard Rome Road, said point also being the point of tangent of said 4° 00' 00" curve to the left; thence north 7° 02' 36" west with and along the existing centerline of Hilliard Rome Road a distance of 154.04 feet to a point on the existing centerline of Hilliard Rome Road and there to terminate.

The total length of the road to be established, altered, widened and relocated being 660.00 feet or 0.125 miles. The right-of-way to be established, altered, widened and relocated to the various widths and locations as shown on the submitted plat, being not less than 120 feet.

The amounts of land to be acquired and the properties through which the establishing, altering, widening and relocating passes are as follows:

WHEREAS, on the 24th day of August, 1967, the Board of County Commissioners of Franklin County, Ohio, did by resolution duly adopted, authorize and direct the Engineer of Franklin County, Ohio, to make a report in writing relative to the establishing, altering, widening and relocating of Hilliard Rome Road, Section "B" Part, County Road No. 3, Norwich Township, to said Board on or before 10:00 A.M. of September 7, 1967, said report to be in manner and form prescribed in Section 5553.06 of the Revised Code of Ohio; and

WHEREAS, the Board of County Commissioners of Franklin County, Ohio, finds that the public welfare and convenience require the establishing, altering, widening and relocating of Hilliard Rome Road, Section "B" Part, County Road No. 3, Norwich Township, as shown on the plat submitted by the County Engineer; now therefore

BE IT RESOLVED, by the Board of County Commissioners of Franklin County, Ohio, that said Hilliard Rome Road, Section "B" Part, herein referred to, is hereby found and determined to be of sufficient importance to the public convenience and welfare to cause the establishing, altering, widening and relocating thereof, as recommended by the County Engineer, and as shown on the plat submitted by said Engineer.
