PETITION TO VACATE AN ALLEY LOCATED IN THE "LEONARD PARK SUBDIVISION, MIFFLIN TOWNSHIP, FRANKLIN COUNTY, OHIO.

In the matter of the petition filed by James DeBlasi, for the vacation of an Alley located in the "Leonard Park Subdivision", Mifflin Township, Franklin County, Ohio, Mr. Cooper offered the following preamble and resolution and moved the adoption of the same, which was duly seconded by Mr. Dorrian.

WHEREAS, on March 22, 1972, the County Commissioners requested the Engineer of Franklin County, Ohio, to determine that the above mentioned Alley has not been used for a period in excess of twenty-one (21) years immediately preceding the filing of this petition and that formal proceedings for the vacation thereon, as provided in Section 5553.04 of this Revised Code has not been taken; and

WHEREAS, on March 29, 1972, the County Engineer, Cletus E. McPherson, did report thereon in writing that said Alley has not been used for a period in excess of twenty-one (21) years and said Alley (as described in the petition and plat) shall be vacated pursuant to Section 5553.042 of the Revised Code; now therefore,

BE IT RESOLVED, by the Board of County Commissioners of Franklin County, Ohio, that the vacation of said Alley (as described in the petition and plat), located in "Leonard Park Subdivision", Mifflin Township, Franklin County, Ohio, be and the same is hereby declared vacated, subject to the perservation of any existing right-of-way in, over in, over or under said alley by any public utility.
