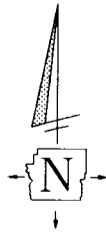

Relocated Bowen Road (C.R. 219)

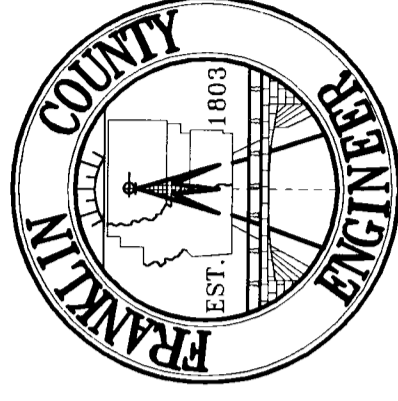
