Voting Aye thereon: Dewey R. Stokes, Arlene Shoemaker and Dorothy S. Teater.

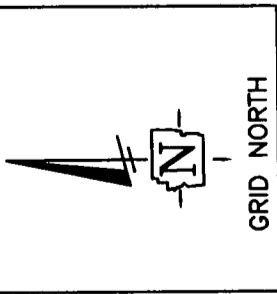
