RESOLUTION TO CHANGE THE SPELLING
OF BEVELHEIMER ROAD TO BEVELHYMER
ROAD, PLAIN TOWNSHIP, FRANKLIN
COUNTY, OHIO, APPROVED
(FRANKLIN COUNTY COMMISSIONERS)

WHEREAS, the Franklin County Engineer is requesting the Board of County Commissioners to change the spelling of Bevelheimer Road, located in Plain Township, Franklin County, Ohio, to Bevelhymer Road; and

WHEREAS, a petition was received by the Village of New Albany from Florence Bevelhymer, who has submitted documentation to the Village showing the spelling was originally Bevelhymer, and requesting that the spelling be changed; and


WHEREAS, the Plain Township Trustees and the Village of New Albany have enacted resolutions to change the spelling of Bevelheimer Road to Bevelhymer Road, within their respective boundary limits; now, therefore, upon motion of Commissioner **Kilroy**, seconded by Commissioner **Shoemaker**,

BE IT RESOLVED, BY THE BOARD OF COUNTY COMMISSIONERS OF FRANKLIN COUNTY, OHIO:


Section 1) That the spelling of Bevelheimer Road, located in Plain Township, be changed to Bevelhymer Road, and a copy of this resolution be certified to the County Engineer, the County Recorder and the County Auditor, who shall change their records accordingly, but still retain in some manner the old name of the road.
