Franklin County Engineer Cornell Robertson, in collaboration with the Ohio Department of Transportation is pleased to announce the improvement of Cleveland Avenue from Huy Road to East Cooke Road. The Engineer's Office has received federal funding to address pedestrian safety issues along the corridor, as pedestrian crashes are more frequent along Cleveland Avenue than other County roadways. From 2016-2018, there were 14 pedestrian crashes, including 2 deaths. The Cleveland Avenue Corridor Improvement Project will improve safety for pedestrians and drivers by adding crosswalks, installing Rectangular Rapid Flashing Beacons at pedestrian crossings, road widening, upgraded street lighting, traffic signal replacements, and raised medians. You are invited to our Online Open House. The goal of this virtual event is to give you an opportunity to learn about the project and provide comments to the County.
