The Franklin County Engineer's Office in conjunction with the Ohio Department of Transportation (ODOT) would like your input on the proposed improvements to Frank Road at the Hardy Parkway Street and Brown Road intersections. The proposed improvements will construct two multi-lane roundabouts on Frank Rd. One at the Brown Rd and Hardy Parkway Street intersection and another east at the Brown Road intersection. This project will also add pedestrian facilities, both sidewalks and shared-use path, include drainage improvements, and have utility relocations. The improvements are necessary to improve safety and reduce crashes at these intersections.

## Frank Road Roundabouts Improvement Project

FRA-CR125-7.89 (Project ID 114801) April 16, 2024

#### **Project Description:**

- » The project proposes to construct two multi-lane roundabouts on Frank Rd. One at the Brown Rd and Hardy Parkway St intersection and another, east at Brown Rd intersection.
- » Additional improvements include installation of pedestrian facilities, lighting, and drainage improvements.
- » Current construction cost estimate is \$9.2 million dollars. \$3.1 million received from ODOT Safety Funding.

#### **Project Purpose:**

» Improve safety, access management, traffic operations, and pedestrian facilities.

#### **Project Need:**

#### 2020 Safety Study

- » Studied intersections of Frank Road & Hardy Parkway St and Frank Road & Brown Road
- » 56 crashes from 2017-2019. 21 resulting in injury, 1 fatality.
- » Identified roundabouts as recommended improvement to address safety and improve congestion.

#### **Potential Impacts:**

#### **Environmental**

» Impacts to one historic structure (1960 Brown Rd) are expected. Potential impacts to culvert on Brown Rd.

### **Drainage & Utilities**

- » Installation of stormwater detention basin.
- » Utility relocations needed


### Right-of-way

» Temporary and permanent right-of-way needed.

#### Maintenance of Traffic

» Maintenance of traffic broken phased approach to maintain one lane of traffic in each direction on Frank Rd. Detours for side streets are likely.



## Proposed Improvements Summary (See reverse for more detailed exhibit)



### **Proposed Improvements Summary**

- » Replace traffic signal at Frank Rd and Brown Rd/Hardy Parkway St with a multi-lane roundabout.
- » Replace existing Stop condition at Frank Rd and Brown Rd tee intersection with a multi-lane roundabout.
- » Reconstruct and widen pavement on Frank Rd, Brown Rd, and Hardy Parkway St.
- » Create a Shared Use Path (SUP) on the South side of Frank Rd between roundabouts.
- » Construct SUP on west side of Brown Rd north of Frank Rd.
- » Build sidewalk on north side of Frank Rd between roundabouts and on west side of Hardy Parkway St and east side of Brown Rd.
- » Reconstruct existing sidewalk on north side of Frank Rd west of Brown Rd
- » Include new curb and gutter, curb ramps, street lighting, and storm sewer throughout the project corridor.
- » A Stormwater Quantity and Quality feature (BMP) will be constructed to meet treatment requirements for the project.
