We are rehabilitating two bridges on Trabue Road, one over the Scioto River and one over Scioto Pointe Drive. #### Existing Bridge over Scioto River, 10.77

- Built in 1973
- Condition Rating: 6  
(scale: 9 = best, 0 = worst)
- 4 lanes of through traffic, 12-foot wide

#### Existing Bridge over Scioto Pointe Drive, 10.89

- Built in 1973
- Condition Rating: 7  
(scale: 9 = best, 0 = worst)
- 4 lanes of through traffic, 1 turn lane, 12-foot wide

#### New Bridge over Scioto River, 10.77

- New concrete deck, beams, and supports
- 4 lanes of through traffic, 1 turn lane, 11-foot wide
- 12'-0" shared use path on the north side of the bridge
- 6'-3" sidewalk on the south side of the bridge

#### New Bridge over Scioto Pointe Drive, 10.89

- New concrete deck, beams, and supports
- 3 lanes of through traffic, 2 turn lanes, 11-foot wide
- 12'-0" shared use path on the north side of the bridge
- 6'-3" sidewalk on the south side of the bridge

**Construction Cost Estimate:** \$11,276,398

#### Schedule

- Design Complete: Summer 2023
- Construction Start: Early 2024

#### Maintenance of Traffic during Construction

- Construction will be completed via a partial road closure, with at least one lane in each direction maintained at all times.
- The anticipated duration is 18 months, starting in Early 2024. This would impact vehicular traffic.
