Existing Bridge

- Built in 1980
- Condition Rating: 5

(scale: 9 = best, 0 = worst)

- Has four lanes of traffic
- 5 foot sidewalks on both sides

New Bridge

- 4 lanes of traffic (10-foot wide)
- 13-foot Shared-use path on south side of the bridge
- 5-foot sidewalk on the north side of the bridge

Other project elements

- 10-foot shared-use path between the bridge and Sunbury Road on the south side of Agler Road
- 10-foot shared-use path on the south west side of the bridge will connect to the Alum Creek Trail

Construction Cost Estimate: \$4,855,000

Schedule

- Design Complete: April 2021R/W Acquisition: Early 2021
- Construction Start: September 2021

Maintenance of Traffic during Construction

- We are considering a full closure that would be for 5 months starting in March 2022. This would impact vehicular and pedestrian traffic.
- Maintaining vehicular and pedestrian traffic across the structure during construction could add 4 months to the duration. This option is also significantly more expensive.
