

Resolution adopting the Franklin County Engineer's annual review and amendment to the 10-Year Capital Improvement Program for Roads and Bridges (Engineer)

WHEREAS, Section 5543.01 of the Ohio Revised Code provides that the county engineer shall have general charge of construction, reconstruction, improvement, maintenance, and repair of all bridges and highways within the engineer's county, under the jurisdiction of the board of county commissioners; and

WHEREAS, the Franklin County Engineer has evaluated the roads and bridges and developed a 10-year Capital Improvement Program for Roads and Bridges based on the urgent need and necessity for certain projects; and

WHEREAS, the scheduling of capital improvement projects allows the public to become aware of long-range infrastructure needs and provides a mechanism for coordination of projects; and

WHEREAS, the proposed 10-Year Capital Improvement Program for Roads and Bridges is subject to annual review and to future revision due to factors including, but not limited to, the changing nature of infrastructure needs, availability of funding, and unforeseen emergency projects; and

WHEREAS, the following infrastructure improvement projects were completed in 2021 and are being removed: Bixby Road 3.45 over Holton Ditch; Borrer Road 0.11 over Tributary of Strader Ditch; Harper Road, Highland Avenue, Valley View Drive and Eureka Avenue; Hoover Road 2.04 over Tributary of Grant Run; Olentangy River Road 10.08 over Turkey Run; Ormond Avenue Drainage Improvement Projects – Phase 2; Refugee Road 5.99 over Big Walnut Creek; Smothers Road at Harlem Road Detention Pond; Toy Road Area Improvement; and

WHEREAS, the following projects have been removed, renamed, or replaced by other projects: Franklin County Roadway Curves Project; Harlem Road at Walnut Street; Sunbury Road at Woodward Avenue; Wilcox Road at Hayden Run Road; and

WHEREAS, the following projects remain from 2021: Agler Road 1.52 over Alum Creek; Alton & Darby Creek Road 1.88 over Clover Groff Run; Alum Creek Drive (State Route 317 to Groveport Road); Brown Road (Frank Road to US Route 62); Cassady Avenue (I-670 to Agler Road); Cleveland Avenue Corridor Improvement (Huy Road to Cooke Road); Commerce Street 0.52 under Norfolk Southern & CSX; Cooke Road (I-71 to Karl Road); Cooke Road (Karl Road to Cleveland Avenue); Dempsey Road (I-270 to
