#### **Project Description**

The Franklin County Engineer's Office invites you to share your thoughts regarding our upcoming project in your area. We are making improvements to Ferris Road beginning at Karl Road and ending at Cleveland Avenue, including resurfacing from Karl Road to Minnie Avenue, and widening from Minnie Avenue to Cleveland Avenue for a total of 1.19 miles. See the Improvements Overview section for all of the improvements. The project's purpose is to enhance the safety, accessibility, and functionality of the existing roadway infrastructure and accommodate all users, including motorists, cyclists, and pedestrians. This will promote non-motorized transportation options, reduce traffic congestion, and improve the overall quality of life for residents and visitors.

#### **Right-of-Way Acquisition**

Permanent and temporary right-of-way will be needed for this project. If right-of-way acquisition is necessary from your property, a real estate representative will contact you directly at a later date to discuss the right-of-way needs, the acquisition process, and your rights under that process.

#### **Ferris Road Improvements Overview**

- Resurfacing from Karl Road to Minnie Avenue
- Widening from Minnie Avenue to Cleveland Avenue
- Two 10' through lanes of traffic
- 5' wide sidewalks on both sides of Ferris
- 5' wide bike lanes with curb on both sides of Ferris
- 8' wide street parking on north side of Ferris
- New crosswalks at all intersecting streets
- Full storm sewer replacement
- Improved intersection lighting
- New signage and pavement markings
