KNOW ALL MEN BY THESE PRESENT, That we, ODOT, as principal, and _____, as surety _____, are held and firmly bound unto Franklin County, Ohio, in the sum of ¹ 4,500 Dollars, to the payment of which sum, well and truly to be made, we do hereby jointly and severally bind ourselves, our heirs, executors and administrators.

Signed by us and dated at Franklin, Ohio, this 13th day of July, 2022.

THIS CONDITION OF THE ABOVE OBLIGATION IS SUCH, That, Whereas, on the 13th Day of July, 2022, the above bond for the Agrabright Ditch Watershed Improvements.

Filed a petition with the Clerk of the County Commissioners of Franklin County, Ohio, making application to the County commissioners to ² clean, construct, install tile, relocate and alter the drainage system as necessary to provide proper and sufficient drainage and extending such work downstream as necessary to provide a proper outlet.

Petitioned for by ODOT, and others, the following being the course and termini of said proposed improvement, to wit:

Commencing

In Franklin County, Pleasant Township, within the Argabright Ditch Watershed and generally following, but not limited to the course and termini of the existing improvements.

Now, if the said ODOT will pay the cost of notices, plus any other incidental expenses, except the cost incurred by the Engineer in making his preliminary reports, if the prayer of the petition is not granted or if the petition is for any cause dismissed, unless the Board of County Commissioners decides to pay the Engineer's costs from this Bond in accordance with Section 6131.09 of the Revised Code, then this obligation shall be void; otherwise it shall be and remain in full force and virtue in law.
