Signed by us and dated at Franklin, Ohio, this 4<sup>th</sup> day of March, 2021.

THIS CONDITION OF THE ABOVE OBLIGATION IS SUCH, That, Whereas, on the 4<sup>th</sup> Day of March, 2021, the above bond for the Golfview Ditch Improvements.

Filed a petition with the Clerk of the County Commissioners of Franklin County, Ohio, making application to the County commissioners to clean, construct, install tile, relocate and alter the drainage system as necessary to provide proper and sufficient drainage and extending such work downstream as necessary to provide a proper outlet.

Petitioned for by Greg Richards, and others, the following being the course and termini of said proposed improvement, to wit:

### Commencing

In Franklin County, Brown Township, within the Golfview Ditch Watershed and generally following, but not limited to the course and termini of the existing drainage system.

Now, if the said Greg Richards will pay the cost of notices, plus any other incidental expenses, except the cost incurred by the Engineer in making his preliminary reports, if the prayer of the petition is not granted or if the petition is for any cause dismissed, unless the Board of County Commissioners decides to pay the Engineer's costs from this Bond in accordance with Section 6131.09 of the Revised Code, then this obligation shall be void; otherwise it shall be and remain in full force and virtue in law.
