

## NOTICE TO CONTRACTORS

Sealed proposals will be received at the office of the Franklin County Engineer until **2:00 p.m.** local time on **May 3, 2016**, and the same will be publicly opened at the same hour at said office for the labor and material necessary for the improvement of **Riggins Road (CR-432) extension from Wilcox Road (CR-40) extending west to Avery Road (CR-3), Franklin County, Ohio.**

**Project Description:** Construction of an extension of Riggins Road from Wilcox Road west approximately 0.65 miles to Avery Road including a roundabout at Wilcox Road and Riggins Road, asphalt pavement, curb and gutter, shared use path, water works, sanitary sewers, street lighting, traffic control, storm sewers and off-site storm sewers and BMP's.

The plans, profiles, specifications, estimates of quantities for doing this work are on file at the Franklin County Engineer's Office for the inspection by all persons interested in the same during business hours Monday thru Friday.

All proposals shall be made on standard bidding blanks furnished by the County Engineer and shall be addressed to the Franklin County Engineer's Office; Attention: Bid Opening; 970 Dublin Road; Columbus, Ohio 43215. The envelope containing the proposal shall be endorsed with pertinent description of the work bid upon and should be hand delivered or sent by certified mail with signed receipt. Copies of the plan and specifications may be obtained from ARC, located at 1159 Dublin Road, Suite 300; Columbus, Ohio 43215, **at a cost of \$135.00 per paper set and \$67.50 per electronic set.** All plans will be sold as a full set, (no partial sales), and all sales are not refundable. All checks must be made payable to ARC. Each contractor, including both prime and subcontractors, are subject to audit by appropriate state entities. As this is a state funded project, all bidders are required to be **PRE-QUALIFIED WITH THE OHIO DEPARTMENT OF TRANSPORTATION** to submit a bid for this project.

**There will be a pre-bid meeting held on April 21, 2016 at 10:00 a.m. at the Franklin County Engineer's Office located at 970 Dublin Road, Columbus, Ohio 43215.**

Proposals must contain the name of every person interested therein and shall be accompanied by a bid guaranty and contract bond for the full amount of bid; or in lieu of the bid guaranty and contract bond the bidder may submit a bid guaranty as provided by Section 153.54 of the Revised Code in the form of a certified check or cashier's check pursuant to Chapter 1305 of the Revised Code. The amount of the certified check or cashier's check shall be equal to ten percent (10%) of the bid. The certified check or cashier's check submitted with a bid will be held as a guarantee on an accepted bid proposal.

The contract is scheduled to be awarded on **May 31, 2016**. At that time, a bid guaranty and contract bond in the sum of 100% of the bid shall be executed in accordance with Section 307.89 of the Revised Code of Ohio. All qualified business enterprises will be afforded full opportunity to submit bids in response to this invitation and no bidder will be discriminated against on the grounds of race, color or national origin in awarding the subject contract.

Certified Check or Cashier's Check will be returned to all other bidders after the Contract has been awarded.

The bidder's address shall be included along with his/her signature on the bid.

The work shall be completed no later than **June 1, 2017**. Upon failure to complete the work within the time specified, the Contractor shall be governed in accordance with Section 5555.67 of the Revised Code of Ohio. No proposal shall be considered unless it complies with all the rules and regulations set forth in the Contract documents. All bidders are urged to carefully read the same and comply with them. The Board of County Commissioners reserves the right to reject any or all bids.
